



Dear parents and carers

Leeds School Streets - Removing traffic outside [add school] to make space for social distancing [add commencement date]

We're pleased to tell you that our school has agreed to take part in a 'School Streets' scheme that will help you, your children and our school community stay safer. This is to make space for people to travel to and from school more safely and reduce the risk of spreading the Corona virus, for everyone's benefit.

To help children, their families and school staff to maintain social distance, Leeds City Council will introduce a Temporary Traffic Regulation Order (TRO) to restrict traffic at drop-off and pick-up times, during term time around [add school] (see map). These types of restrictions are known as School Streets, and they have the support of the local councillors. If successful, this temporary TRO could become permanent.

School Streets will help people who are walking, riding bikes or on scooters by providing extra space on the road. The council will put signs in appropriate places so you know which roads are reserved for people on foot, bikes or scooters, along with the times. Non-residents will not be allowed to drive through (residents who do need access will be asked to drive at a walking pace). Emergency vehicles and Blue Badge holders will have access at all times.

The School Streets scheme will also have other benefits:

makes the air around school fresher and cleaner gives children the chance to get to school 'actively', which helps them stay healthy makes roads safer for everyone.

We look forward to welcoming your children back; please help us all by walking, cycling or scooting to school if you possibly can. Thank you for your cooperation and for helping everyone to stay safe.

Dear parent / carer. As part of the new Schools Streets scheme (Leeds City Council Covid-19 response), you will not be able to drive on the following roads around Cross Gates Primary School from 8 June 2020: Maryfield Crescent (Maryfield Avenue to Poole Crescent); Poole Crescent (between its junctions with Poole Road); Poole Road (between its junctions with Poole Crescent); Farm Road (between its junctions with Poole Crescent); the whole of Poole Mount. Diversions: using Thornfield Drive, Thornfield Way, Farm Way and Poole Crescent. Please check www.leeds.gov.uk/schoolstreets for alternative parking if you need to park and stride. Thank you for helping us keep everyone safer.









Park and Stride/Glide

Advice to families, parents and carers

Parking is available in the large car park in front of Crossgates Community Centre. Exit the car park using the footpath onto Maryfield Avenue, then it is a short walk to school along Maryfield Crescent (see map for details). Alternatively, you may be able to find on-street parking on local streets outside of the pedestrian and cycling zone.

If parking on local streets, please be mindful of local residents. Do not park across driveways, on grass verges or on pavements. Pavement parking makes it really difficult for people walking, especially those with young children. Park away from bends and junctions, so that people crossing the roads can see any traffic.


When walking or scooting from where you park to school, we advise you to:

- Be aware of other people using the Community Centre car park if using this location and the movement of vehicles
- Be aware that there may be litter, including glass, in the car park (requests have been made to have the area cleaned)
- If you have to cross any roads, use crossing facilities where available. If they are not available, use the Green Cross Code to get over roads safely
- If scooting, be aware of the surface and look for uneven pavements. Control your speed on downhill sections (such as on the footpath out of the car park) and get off your scooter and walk when crossing roads
- If walking on narrow paths, such as the footpath from the car park, keep left and walk in single file to allow for social distancing. Signs will be in place to remind you of this.

Leeds School Streets - Removing traffic outside Cross Gates Primary School to make space for social distancing commencing 1st June 2020

To help children, their families and school staff to maintain social distance, Leeds City Council will introduce a Temporary Traffic Regulation Order (TRO) to prohibit traffic at drop-off and pick-up times, during term time around Cross Gates Primary School (see map). These types of restrictions are known as School Streets, and they have the support of the school and local councillors.

School Streets will help people who are walking, riding bikes or on scooters by providing extra space on the road; non-residents will not be allowed to drive through. This is to make space for people to travel to and from school more safely and reduce the risk of spreading the Corona virus, for everyone's benefit. Emergency vehicles and Blue Badge holders will have access at all times.

We will put signs in appropriate places to tell drivers which roads are reserved for people on foot, bikes or scooters along with the times. We are also working to identify 'Park and Stride' locations to help support families who have no choice but to drive to school.

The School Street will also have other benefits:

- clears school-related congestion from your neighbourhood
- makes the air where you live fresher and cleaner
- gives children the chance to get to school 'actively', which helps them stay healthy
- makes roads safer for everyone.

Residents and businesses in a School Street will still be able to access these roads by car during the restrictions, though we do ask you to avoid driving on these streets during restricted times if at all possible. If you do need to use your car, please:

- display the temporary resident and business access permit in your windscreen
- it would help if you would drive at walking speed, i.e. 5mph.

If you need an extra permit for your household, please get in touch.

Please find your temporary permit below

This temporary permit allows a resident or business located within a School Street to access these roads by car during the closure, though we do ask you to avoid driving on these streets during closure times if at all possible.

If you do need to use your car, please:

- write the vehicle registration in the box provided below to validate the permit
- display the temporary access permit in your windscreen
- drive at walking speed, i.e. 5mph (you may be escorted by a steward).

All permit holders must comply with the terms and conditions.

Terms and conditions

- 1. Do not amend this permit.
- 2. Any amendments may result in a Penalty Charge Notice (PCN) being issued.
- 3. This permit can only be used by a resident or business residing or operating within the School Street specified on the permit.
- 4. This temporary permit is only valid for the dates shown.
- 5. The permit must be clearly visible from outside the vehicle.
- 6. This temporary permit must be destroyed when any new permanent permit is received.
- 7. This permit remains the property of Leeds City Council and must be surrendered to an authorised officer upon request.

NOTICE IS HEREBY GIVEN that because of the likelihood of danger arising to the public (School Streets), Leeds City Council intends in not less than 7 days to make an Order the effect of which will be that no person shall cause or permit any motor vehicle to proceed on the length(s) of road defined on the days and between the times shown in Schedule 1 hereto.
